A) I _____, represent that:

- The Dog is not a trained guard or protection dog.

B) Dirty Paws is authorized to seek medical care for the dog if deemed necessary by it or its employees and is allowed to approve medical care if it is deemed necessary by a veterinarian.

I agree to pay all costs associated with attending to the Dog's medical needs

C) If Dirty Paws is unable to walk the dog on a specific day, we will inform you as promptly as possible.

D) I release all rights to any photographs taken by Dirty Paws of my dog for the purpose of advertising and promotional uses for Dirty Paws Dog Walking

E) Dirty Paws reserves the right to terminate this contract for any reason provided 24 hours notice is given.

F) You (the client) have the right to cancel any specific day or week of walks provided 24 hours notice is given, if less than 24 hours are given you agree to be charged full rate for the day(s) in question.

G) I agree to allow Dirty Paws access to my home to walk my dog.

H) I agree to license my dog in my municipality, if my dog is not licensed I agree to pay any fines associated, incurred by Dirty Paws or its employees when my dog is in their care.

I) I agree and understand Dirty Paws Dog Walking will be transporting my dog in their vehicles to North Vancouver or West Vancouver where my dog will be walking/hiking for a period of no less than 1.5 hrs off-leash.

J) When using Dirty Paws for boarding services, if requested, I agree to pay a 50% non-refundable deposit on any boarding booked. 48hr cancellation notice required, otherwise you agree to pay full boarding rate for day(s) in question.

K) Full payment for all services due and payable by cash or e-transfer on receipt of invoice.

Release, Waiver and Indemnity (the "Release")

BY SIGNING THIS RELEASE, YOU ARE WAIVING YOUR LEGAL RIGHTS AND GIVING UP THE RIGHT TO SUE. PLEASE READ CAREFULLY.

ASSUMPTION OF RESPONSIBILITY AND RISK

I REALIZE THAT THERE ARE RISKS, DANGERS AND HAZARDS INHERENT WITH WALKING DOGS IN THE OUTDOORS, TRAVEL RELATED THERETO AND ACTIVITIES NECESSARILY ANCILLARY TO SUCH ACTIVITIES (the "Services").

I freely and voluntarily accept and assume all such risks, dangers and hazards, both usual and unusual, and the possibility of injury, death, violence, property damage or loss, resulting from or connected with the Services. I understand that, in order for Dirty Paws to provide the Services, I must freely and fully accept and assume full responsibility for such risks, dangers and hazards associated with the Services and the possibility of injury, death, violence, property damage or loss, resulting from or connected with the Services.

RELEASE OF LIABILITY; WAIVER; INDEMNIFICATION

In consideration for my Dog being walked by Dirty Paws and the provision of the Services, I agree to waive any and all claims, actions, causes of actions, including negligence, claims and demands for damages, loss or injury (collectively, "Claims") that I have or may in the future have against Dirty Paws, Courtnay Huber or any other persons employed by, or associated with, Dirty Paws (collectively, the "Releasees"), from any and all liability for injury or death to my Dog, and for any loss, damage or expense of any kind that I may suffer, due to any cause whatsoever, including negligence, breach of contract or breach of any legal obligation of any kind on the part of the Releasees. I irrevocably and unconditionally release and forever discharge the Releasees from any and all such Claims (including any Claims from my spouse or other person claiming to be the owner of the Dog which is subject to the Services), and I hereby agree to indemnify and hold the Releasees harmless from all such Claims. Without limiting the Standard Terms and Conditions, I also agree that I will be responsible for any loss, damage or medical expenses of any kind caused or claimed by any other person alleged to have been damaged by the Dog in any way while in the care of the Releasees, and I agree to fully indemnify and save harmless the Releasees from any liability or legal claim relating to the Dog or my breach of the Agreement, including for any and all legal fees and expenses that the Releasees may incur.

GENERAL

I agree that this release and waiver is intended to be as broad and inclusive as permitted by the laws of the Province of British Columbia.

This Release shall be effective and binding on my heirs, next-of-kin, executors, administrators, assigns and representatives.

I am not relying on any statement or representation of the Releasees in signing this Release.

I am the legal owner of the Dog. I have read and understood this Release, and **I UNDERSTAND THAT BY SIGNING THIS RELEASE I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS MAY HAVE AGAINST THE RELEASEES.**
